BATAVIA DOWNS GAMING "Call Your Shot for a Million Bucks" 25-02 Official Rules

- 1. Eligibility: This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-ground employees, and vendors directly associated with this contest, their subsidiaries, affiliates, and agencies are ineligible to participate in the program. Any employees of sponsors and affiliates of the drawing prize and their immediate family members who live in the same household will be ineligible to win the drawing. Drawing Rules (if applicable): If a present winner cannot produce ID, the following protocol shall be followed: For all Drawings \$999 or less the Batavia Downs staff present shall take down the possible winner's driver's license number found in the Player Tracking System. At any time within 24 hours, the possible winner must return, WITH the driver's license that matches the driver's license number that was logged, and the prize will be awarded. If the person fails to show, the prize is forfeited. For all drawings \$1000 or more, the staff present shall take down the possible winner's driver's license number found in the Player Tracking System. The possible winner must designate a 1-hour window within the following 24 hours of the drawing time to return to claim their prize by presenting the driver's license that matches the driver's license number that was logged. 4. Contest Period:

Virtual Drawings:

Winners from Saturday Jan 1, 11, 18, 25 and Feb 1, 8, 15, 2025 will also be returning with the chance to roll the dice, between 6-7pm

If any winners from the previous dice roll drawings (held in January and Feb 1, 8, 15, 2025) do not come to claim their dice roll attempt on February 22nd before 6:00pm and do not make other arrangements with Batavia Downs Marketing staff to arrange a later attempt on February 22nd, their prize is forfeited. A new name(s), different from all previously selected virtual drawing winners for the dice roll opportunity, will be chosen to take their place in the dice roll game via a hot seat drawing at 6:00pm. The winner must be present and will receive 2 free dinners, and a dice roll with the potential of winning \$1,000,000.

Virtual Drawing: From January 1-February 22, 2025, customers playing at any BDG machine with their Player's Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. *To activate entries, players must play with their OWN players club card between (TIMES LISTED IN DRAWING) before drawing announce times. Once drawn, the earliest play activating entries will be checked by staff to confirm play by player with their own card. If a player is found to not be playing with their own card at that time, they will NOT be deemed an eligible winner for that drawing and a new winner will be selected. (If a winner is not found after 5 pulls for the virtual drawing, the 6th drawing will move to a Hot Seat drawing to find a winner.*

(1 correct dice roll = \$250 cash, 2 correct dice = \$500 cash, 3 correct dice roll = \$750 cash) Zero correct dice roll with receive a dinner at any of our food outlets, which expire in 1 week from date of issue.

<u>7:30pm</u> - Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. To activate entries, players must play with and remove their Player's Club Card between 6:00:00pm-7:00:00pm. The winner will be drawn at 7:20pm. The winner will be announced at 7:30pm. Once chosen and called, the winner of the drawing will have 5 minutes to report to the Player's Club to claim their prize. Players MUST be present to win. Promotional giveaways are executed using the highest standards of integrity.

<u>8:30pm -</u> Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. To activate entries, players must play with and remove their Player's Club Card between 7:00:00pm-8:00:00pm. The winner will be drawn at 8:20pm. The winner will be announced at 8:30pm. Once chosen and called, the winner of the drawing will have 5 minutes to report to the Player's Club to claim their prize. Players MUST be present to win. Promotional giveaways are executed using the highest standards of integrity.

<u>9:30pm -</u> Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. To activate entries, players must play with and remove their Player's Club Card between 8:00:00pm-9:00:00pm. The winner will be drawn at 9:20pm. The winner will be announced at 9:30pm. Once chosen and called, the winner of the drawing will have 5 minutes to report to the Player's Club to claim their prize. Players MUST be present to win. Promotional giveaways are executed using the highest standards of integrity.

Any person selected for the virtual drawings on this night must be different from any previously selected virtual drawing winners for this same prize. If a person was chosen via hot seat to replace a dice roll opportunity no show, they are still eligible for these drawings.

6. Prizes:

Virtual: \$2,000 Cash and the ability to roll 4 (four) dice which could be worth up to \$1 Million Dollars (\$25,000 per year in a 40-year annuity). Plus: \$250 Cash for every correct dice roll. (1 correct dice roll = \$250 cash, 2 correct dice = \$500 cash, 3 correct dice roll = \$750 cash)
